### **COMPUTER LAB:**

The Institute has a well-furnished Computer Lab with adequate number of computers with LAN and Internet Connectivity. A high speed (100 Mbps) internet connectivity is available through National Knowledge Network (NKN) provided by the ministry of communication & IT, Govt of India. The Institute is fully equipped with video conferencing facility, Audio-Visual Computer aid and LCD projector etc.

### LIBRARY:

The Institute's library has a comprehensive collection of literature predominantly related to cooperatives, management, computer and allied subjects to meet the present and future information needs of its users. NSRICM encourages the use of its library for professional purposes. Individuals and cooperative Organizations can use the library regularly for research purposes. The library has a total collection of about 14000 volumes of books, many Journal and magazines, different language-based newspaper etc.

### **HOSTEL:**

An atmosphere of community living prevails on the campus. The campus has a wide range of hostel facilities. The hostel is having a provision for about 120 trainees which is spread over an area of 1.24 acres. Amongst the 60 rooms, one is Guest Room with AC, 3 nos. of Deluxe Rooms. It is equipped with high-speed internet connectivity a pantry and everything that students are likely to need for a comfortable stay.

The excellent sports and fitness facilities on the hostel campus ensure that students can remain fit and healthy to take on the strenuous academic challenges.

### HOW TO REACH THE INSTITUTE:

The Institute is located at the central place of the Kalyani town under Nadia district of West Bengal. It is located adjacent to the Kalyani Main post office and is about 50kms away from Kolkata connected through local train services from Sealdah Terminus and express bus service from the metro city Kolkata.
