VACANCY CIRCULAR

Subject: Filling up the post of Director Vaikunth Mehta National Institute of Management (VAMNICOM), Pune – regarding

The post of Director in the pay scale of Level 14 of Pay Matrix of Rs. 144200-218200 (Pre-revised PB-4 of Rs. 37,400-Rs,67,000 with Grade Pay of Rs. 10,000) with usual allowances as admissible to Central Government Employee, is proposed to be filled up in Vaikunth Mehta National Institute of Management (VAMNICOM), Pune, a training unit of National Council for Cooperative Training (NCCT), New Delhi on **contract basis** for a period of three years, through Search-cum-Selection process. NCCT is a registered society under the aegis of the Ministry of Cooperation to meet the changing requirement of human resource development in the Cooperative sector in the country.

2. The eligibility criteria for appointment to the post of Director (VAMNICOM) is as under:

(i) Educational qualification:

(a) Essential: Full time Post Graduate Degree/Diploma with minimum 55% marks in Social-Science/Economics/Cooperation/Commerce/Business Administration/Agriculture/Information Technology from a recognized University or institute

(b) Desirable: (i) PhD in relevant subject (ii) HDCM/Diploma/PG Diploma in Cooperative Management

(ii) Essential experience:

Minimum 15 years Administrative & Academic experience in senior executive capacity or Head of the Institutions, in recognized University/Institute/Cooperative Training Organization/Cooperative Institute/ Cooperative Department/Govt. organizations/Semi Govt./PSUs/Autonomous Body including similar private organizations.

3. The vacancy is also being advertised in the Employment News/Rozgar Samachar etc. Applications in the enclosed proforma of interested and eligible officers who can be spared in the event of their selection may be forwarded, in duplicate, to this Ministry within 30 days from the date of advertisement of this vacancy in the Employment News/Rozgar Samachar. While forwarding the applications, it is mandatory to verify and certify that particulars furnished by the officer are correct. The following documents also need to be sent along with the application as applicable to parent organization: -

- (i) Vigilance clearance that no vigilance case is either pending or contemplated against the candidate
- (ii) Integrity Certificate;
- (iii) Major/Minor penalty statement during last ten years;
- (iv) Cadre clearance from the cadre controlling/appointment authority, if applicable; and
- (v) Photocopies of ACRs/APARs of last 5 years i.e. 2018-19 to 2022-23 duly attested on each page. If for some reasons, the APARs of the officer have not been written for a particular year or a part (for more than three months) of a year, a "No Report Certificate" (NRC) for that period may be sent along with APARS of the corresponding previous years.

Note: The above requirement may be relaxed in case of candidates coming from private sector.

4. The maximum age limit for his appointment by contract basis should not exceed 56 years as on the closing date of the receipt of the applications.
5. Applications should be sent through the Cadre Controlling Authority/Department to the Director (CTP-II/CET), Ministry of Cooperation, 2nd Floor, Atal Akshaya Urja Bhawan, Lodi Road, New Delhi-110003. A checklist of documents with the application may also be sent.
